Many thanks to **Barbara Colonnello** for inviting me to contribute to an interesting **Shipping 4.0** Panel discussion yesterday in the **European Parliament** with distinguished experts and colleagues.

I was pleased to share **Assarmatori Shipowners Association's** perspective on key topics such as the interface between global vs regional (EU) shipping regulations, impacts of **#CII**, **#ETS** & **#Taxonomy**, **#coldironing**, **#alternativefuels** bunkering, **#ports'** competitiveness & resilience factors.

I underlined that regulations, including international ones, must be not only "well-meant". They must be, above all, "well-made": they need to work in practice to effectively reach their desired goals while minimising unintended negative consequences. This is all the more the case for a "regulation-intensive" sector like shipping. As examples, I referred to the impacts of current **#CII** metric flaws and EU **#Taxonomy** spill-over ramifications from **#Italy's** perspective.

An "ambitiously pragmatic" attitude from regulators, holistic approach, mutual trust and industry-wide cooperation are more than ever needed to reach common goals and make the necessary energy transition of the sector happen!

"Yesterday I was honoured to moderate the panel on 'Ports and Circular Economy Potential' during the 'Shipping 4.0' Conference which was hosted at venue of the European Parliament and which saw the participation of: [Valter Selén](#), [Katalin Dobránszky-Bartus, PhD](#), [DARIO BAZARGAN](#), [Flavio Tonelli](#), Giancarlo Poddighe (CeSMar).

It was a very useful opportunity to debate on a high level about these topics: Ports Governance, fair competition and correct application of the community regulation 352/2017, need of coordination among the several measures dedicated to transition, the impact of taxonomy on private and public investments with a specific focus on the fleet renewal decree.

I personally thanked Marco Campomenosi (Member of the European Parliament), also on behalf of Confitarma and ECSA, for his constant support to our position on the new Basel Rules on bank regulation which will give a strong push on transition investment if Trilogue would approve the version already approved by the Parliament.

We should remember that "without green ships we'll never get green ports"; it is therefore essential to ensure a proper and adequate public financial support for the renewal of the fleet.

Thanks again to my colleagues for the passionate and sharp debate, a special thanks goes to [Barbara Colonnello](#) and her team for the perfect organization.
